#### ***Sovereign Rule and the Still-Birth of Republican Freedom: A Preface to Confederal Republicanism***

Most modern political theorists, whether they have a positive or negative conception of liberty, fail to grasp the intimate dependence of human freedom on the complex organization and culture of a wide range of intersecting, parallel, and nested social groups. It is this theoretical blindspot, I argue, driven by a reductively individualist social ontology, that leads modern political thinkers of many different stripes to view the State, rather than social groups, as the primary guarantor of social order and freedom. Once we reject this individualistic approach, we are able to investigate what sort of institutional and cultural conditions are likely to support citizens’ access to opportunities for rational self-government and personal and group flourishing. This is precisely the task I set myself in this book, starting out from a neo-Aristotelian conception of freedom as rational self-direction in the service of the good.
